- Please provide at least three unique name options. Do not use punctuation marks or numbers.
 Name may not exceed 21 characters and spaces combined. Do not use names that sound similar to existing names, even if spelled differently.
- Application must be accompanied by at least four (4) clear, close photographs of the horse.
 These photographs must include each side and the front and rear views. Please do not trim or mark on the photographs. If the horse is freeze-branded, a photo of brand must accompany application.
- If the horse has minimal white qualifying areas, submit additional photographs of this area with a ruler.
- If photographs submitted do not clearly establish eligibility for Regular Registry, the horse will be registered into the Solid Paint Bred Registry.
- Include payment for all applicable fees. Most current fees apply—see <u>APHA Rule Book</u> for details.

Horse to be Registered

- Any erasure or alteration of horse information or dates will invalidate this breeder's certificate.
 Complete a new application if sire or dam information is incorrect as printed.
- Sire requirements must be met prior to the registration of any foal.
- Corrections to owners' names and addresses are acceptable.
- If this is a QH or TB mare's first APHA foal, include a QH/TB mare enrollment fee of \$49**.
- Dam owner at the time of foaling may register the foal online.
